SUBJECT: April 2015 Income Tax Collection Update

---

Please find attached the summary reports for income tax collections for the month of April 2015. April 2015 income tax collections are above April 2014 collections by \$418,033 or 26.98%. Year to date collections are above 2014 year to date collections by \$717,235 or 10.77%. Year to date actual collections are above year to date estimates by \$580,103 or 8.54%.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. April 2015 collections were above the prior year reporting for withholding and net profit accounts and below for individual accounts. The breakdown of collections for the month of April 2015 is indicated below:

- Withholding accounts equate to 68.54% of collections.
- Individual accounts equate to 5.47% of collections.
- Net profit accounts equate to 25.99% of collections.

In comparison, April 2014 collections were as follows:

- Withholding accounts equate to 78.09% of collections.
- Individual accounts equate to 7.86% of collections.
- Net profit accounts equate to 14.05% of collections.
