SUBJECT: December 2020 Income Tax Collection Update

Please find attached the summary reports for income tax collections for the month of December 2020. December 2020 income tax collections are above December 2019 collections by \$275,969 or 15.20%. Year to date collections are above 2019 year to date collections by \$71,783 or 0.27%. Year to date actual collections are above year to date estimates by \$408,688 or 1.57%

Income tax collections are reported as three different account types: withholding, individual and net profit filers. The following table reflects the year to date revenue received from each of the three components – withholding, net profit, and individuals.
