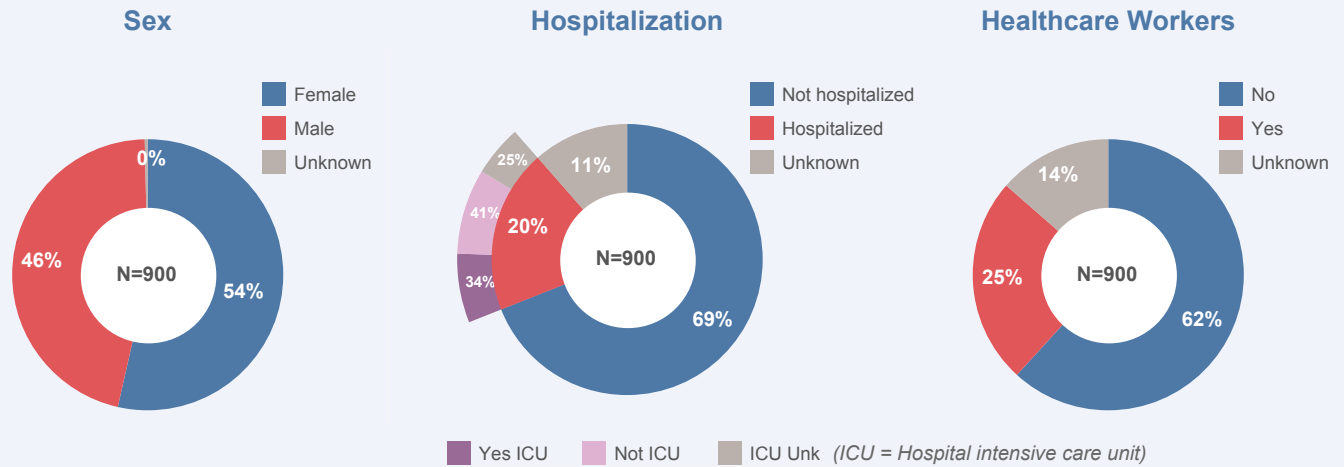

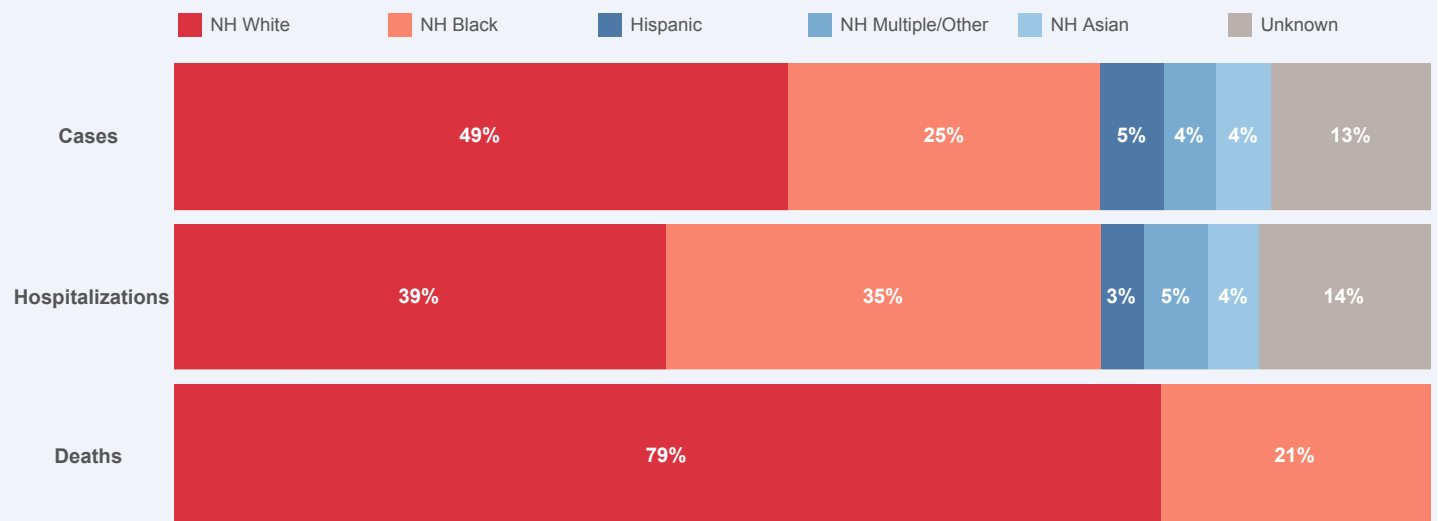

(NH = Non-Hispanic)

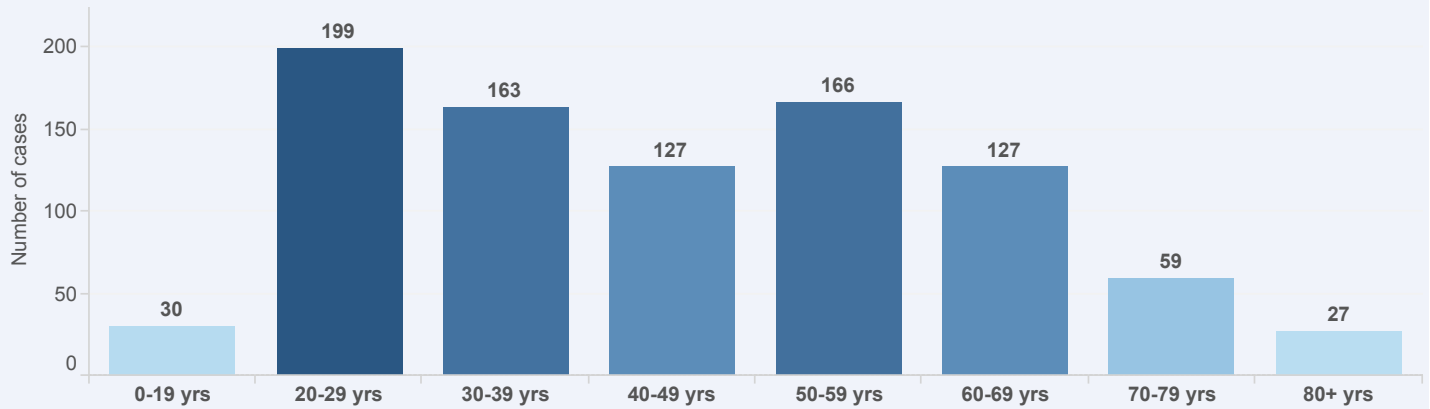

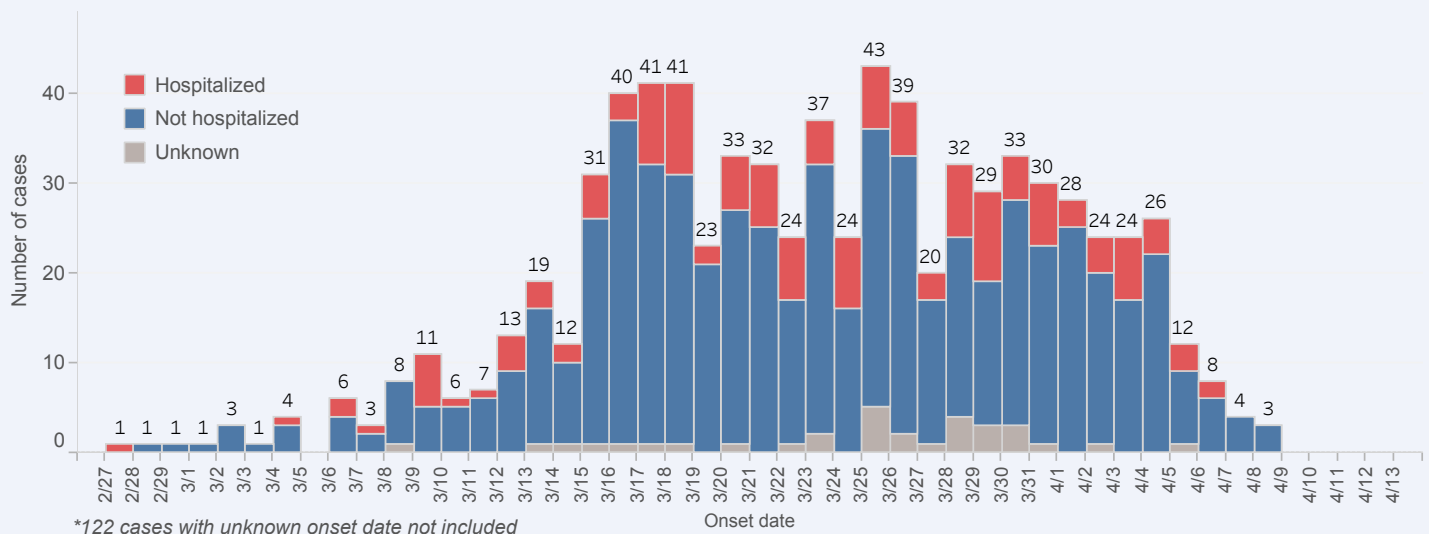

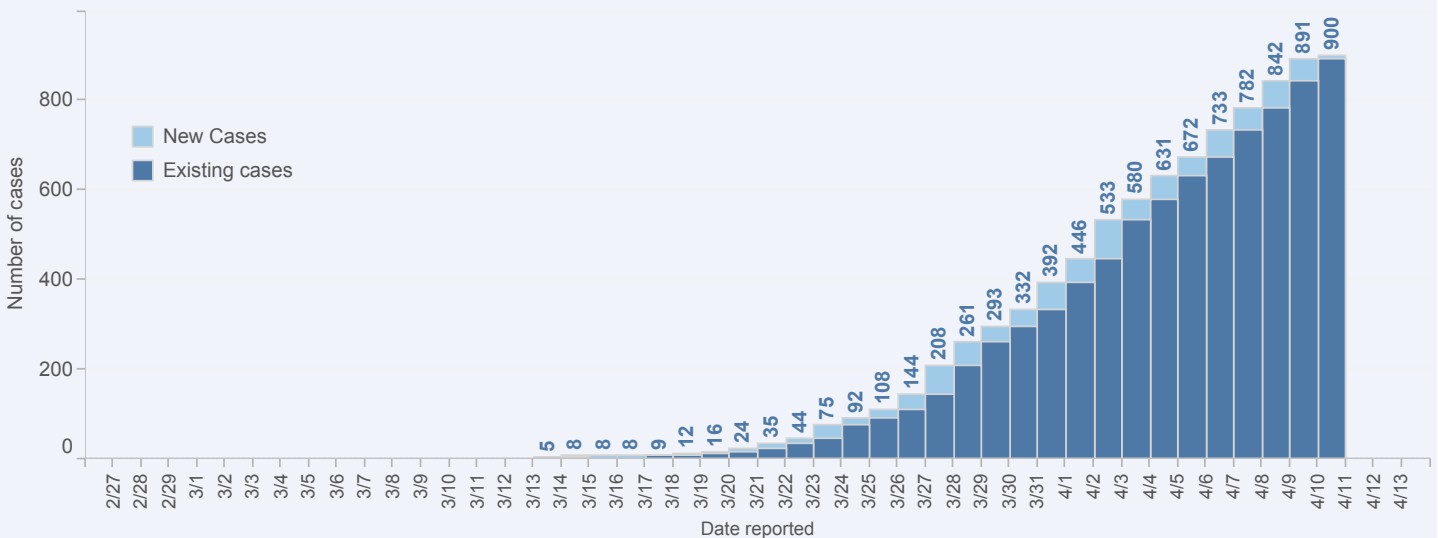
Age Group



Epi Curve for Columbus & Franklin County by Date of Illness Onset (N = 778*)



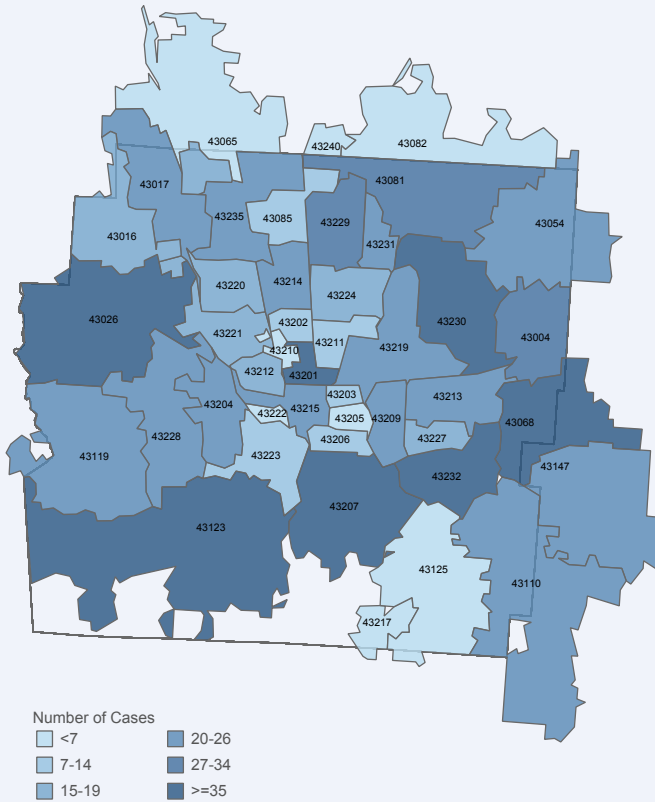
Cumulative Cases for Columbus & Franklin County by Report Date (N = 900)



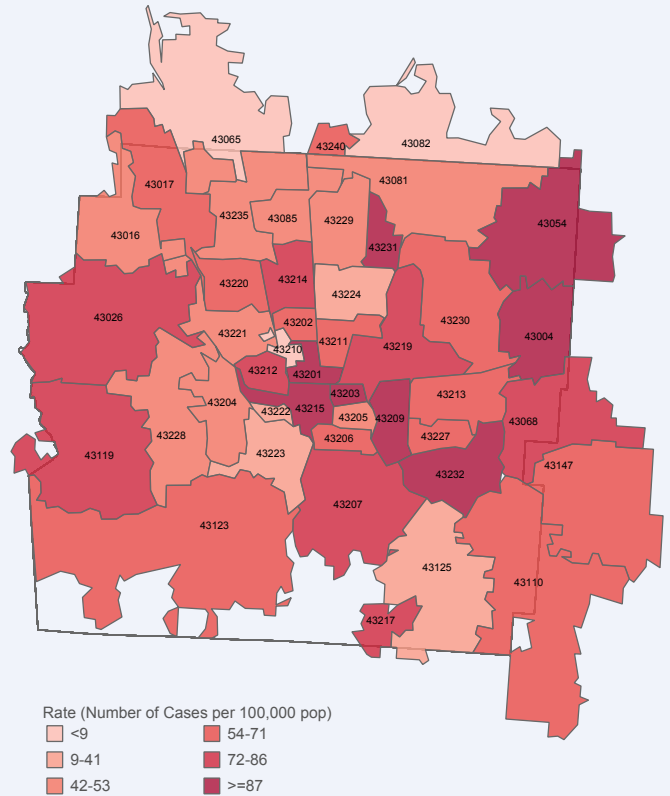

Note: COVID-19 cases outside Columbus & Franklin County jurisdictions are not included in the map; for ZIP codes that cross into other jurisdictions, the number of cases given may not represent all COVID-19 cases in that ZIP code. Additionally, for rate calculations, the entire population of each ZIP code is used. For ZIP codes that go beyond both jurisdictional boundaries, rates can be under-estimated and less reliable due to undercounts of numerator values. Population data for rates are from the US Census Bureau, American Community Survey 2018 5-year estimates.
